Competitive hockey is concluded for the season

Tri County:

- Start of season/try out calendar as presented by OHF with staggered September start for ages. Still need to delay start until after AAA/AA tryouts start so actual dates for A will be finalized by AAA/AA dates.
- U9 will be called MD (not rep A/AA etc.) and will remain tiered as per prior years. No change to season pathway or structure (remain ½ ice until Jan then full ice for balance).
- U11 will play 20 game season Oct 11 Mar 4
- U13 U15 will play 30 game season Oct 1 Mar 4
- U16 will play 28 game season Oct 1 Mar 4

- U18 will play 24 game season Oct 7 Mar 4
- Teams (exclude U9) allowed to participate in 3 tournaments (excluding Christmas and March break)
- Playoffs will be round robin tournament style March 5 March 27. Teams will advance from the TC playoffs to the OMHA playoff weekend. Number of teams advancing to OMHA's is weighted by the size of your league ie TC may have more teams than Bluewater or York/Simcoe division). Minimum of 3 games for every team. No games on March break (Friday to Sunday).
- OMHA will be looking for centres to host OMHA weekends at the various levels (age and A/AA) etc.
- Hockey Canada does not recognize "AE". This year AE will continue in the OMHA but the following season changes are expected.

 - o [Brett] I'll address each option individually:
 - If no interest: Continue to recruit/persuade until someone steps up, we can't not have a President. Typically, the second in command (VP of Rep) would act as President but that is vacant too. Then I think it would fall to the Past President.
 - If no one is qualified: Then the membership must vote to allow an "unqualified" nominee since no qualified nominees exist.
 - Typically, the President role has come with some significant "arm twisting" to existing executive members. So, if there are some existing VPs (or even directors) that would consider President/VP of Rep, start twisting.
