**OMHA AGM.** OMHA AGM was virtual meeting on Jun 12. Nadia and Nathan attended on behalf of Woolwich. 20 motions were tabled: mostly minor by-law wording changes. No major outcomes that affect Woolwich Minor Hockey.

#### Season Structure Updates.

- U9 elimination of all competitive (Representative) categories deferred one year
- AE no longer being identified as stand-alone category deferred one year
- HCR 3.0 WMHA 'go live' targeting first half of July
- 2021/2022 Playoff structure clarification:

- Tri-County to have a tournament style championship (Mar 5-10, 21-27). There will be a playoff round robin followed by qualifying teams participating in a quarter finals / semi final (depending on required teams) weekend. Winners from the Tri-County championship weekend will qualify for the OMHA Championship weekend. Woolwich has notified Tri-County of interest to be a potential host for a Tri-County championship weekend (age category TBD); however, more information is needed from Tri-County
- OMHA Weekend (April 1 -10) will have 5 geographical areas chosen to host the weekends and there is no association bidding to host these events
- OHF Championship Weekend (Apr 22-24) Host Rotation still applies. As a result of the cancellation of the 2020 OHF Championships due to COVID-19, the Host Rotation for 2020 has been frozen and will remain the same in 2021.
  OMHA 'A' host age categories include: U11A and U15A

**Woolwich Weekend Tournament.** David Volpato volunteering to chair Woolwich Weekend Tournament committee. Donna to submit Nov 5-7 as the proposed dates to OMHA in June. U13 Minor/Major and U15 Minor/Major ages to participate. Woolwich teams mandatory. Committee to determine tournament cost, rules and structure over the next few months as soon as tournament is approved/sanctioned.
