## 1. Hockey Coach Vision App (HCV)

This should be detailed first so we can then go back to Larry Huras with the number of HCV app purchase we are looking for.

### 16. Spiritwear – Rob Alles

- I have met with PK Sports and Sportzone to discuss spirit wear for 2016/2017 season. Both vendors have submitted updated product offerings and pricing. Previously the two vendors were each carrying a different percent of sales for WMHA on spirit wear. Moving forward both vendors will add 20% mark up to their cost of any products that have the WMHA logo. The portion of the proceeds for WMHA will be paid out once at the end of the season, (likely in April).
- Woolwich Minor Hockey, Sportszone and Bauer have a contract for the 2015/2016, 2016/2017 and 2017/2018 seasons for Bauer rebates. Vince has confirmed that we will receive \$1,500 from Bauer for the 2016/2017 season. This is great that Vince was able to negotiate this for WMHA. We are not buying enough from Bauer currently to qualify for a \$1,500 rebate. Our current sales on Bauer gear from last season (approx. \$30,000) would earn us

roughly \$600. In addition to Bauer bucks; Sportszone has provided team pricing which in includes a 25% discount on equipment and apparel. New this year, embroidered Wildcat logo on hockey gloves.

- The Bauer warm up suits are changing for 2017/2018. More details for follow.
- WMHA should consider supporting Bauer and Sportszone when tendering socks, new jerseys and team warm up jerseys to help increase the sales in the Bauer program. Sportszone has requested that WMHA have one person only, as an authorized purchasing agent. This person would be responsible for using the Bauer bucks for in store purchases. This money needs to be spent before the end of April each season.
- PK Sports was interested in selling Bauer warm up jackets this coming season.
   This is not an option at this point. Our association needs to purchase through
   Sportszone as per our contract with Bauer.
- All of our current coaches have copies of the 2016/2017 brochures from PK
   Sports and Sportszone. This information has also been updated on the WMHA
   website. The coaches have been encouraged to submit team orders now or
   early this summer; to avoid competing orders in the fall with other
   teams/associations.
- Rob Alles will be the point person dealing with Sportszone regarding Bauer Bucks. Rob will look into the Bauer Bucks for last year and if this money is still available. Bauer Bucks will only be used for purchasing for tournament prizes and not equipment.
- Rob Alles to research Rep Teams purchasing own jerseys for next year. They would have sponsor bars that could be ordered ahead of time and added to the jerseys with Velcro. Teams would be able to substidize the cost with fundraising or sponsorships if they chose.
