17. Concussion Management – Vacant

- Sheila was at the meeting to discuss the Concussion Program
- The website has not been updated with what to do
- 377 players have completed the concussion testing. Education and handouts to everyone.
- Communication is the issue between coaches, trainer and player
- Currently 5 concussions reported 4 PeeWee and 1 Bantam
- Problem that arised was Physician not following protocol. Kids not telling and Parents and Trainers not asking specific questions
- Even one symptom is classified as a concussion after an incident which is a hit to the head and shakes up the brain. The player could have more symptoms or issue the next day.
- Protocol is to see a doctor first. A sports doctor would be the best to see but it is the parent's decision.
- If an incident, then the trainer pulls the player off the ice and trainer needs to report. The player would see a doctor of their choice. A retest at Woolwich Physio would need to be done. If there is a concussion steps need to be followed in order to return to play. Hockey Canada requires a note from a Physician.
- Brett to put together a policy to add to the Website. Form for the Trainers regarding what they can do.
- Suggested that the Trainer hand out a form with the info to the parent when the incident occurs.
