## 5. Reports

These reports provide a high level overview of the activities performed by Paid Staff, Officers and Directors through committees over the season.

#### 5.1. President - Barry Keen

What a crazy season, unlike anything WMHA has ever seen before! Never has a season come to such an abrupt end and not being able to complete playoffs for both Rep and Local League. I didn't think in a million years something like this could happen. But Covid is not the only thing that happened.

Here are some of the positive things that happened this season;

- The Sunrays decided to go on their own, they had started a number of years ago under the WMHA umbrella and now were confident enough to go it alone.
- We joined the Woolwich Wild in regards to the Ip program equipment, working cooperatively, sharing the equipment giving a little more flexibility to both associations' ice schedules.
- We also got together with the Township, Elmira Refereeing Association and the Woolwich Wild regarding the behavior in the stands, on the benches and encouraging young people to become referees. This is something we will continue to work at.
- We had two successful tournaments the Woolwich Juvenile Weekend and the Woolwich Cup
- Local league broke away from GRLL to try an "Interlock League" with Center Wellington
- LL players were also able to try out for Select, which has not been previously offered.
- We had another very successful First Shift program.

As you can see above we have had so many exciting successes, that even though the season came to a disappointing end, we really did have a good year.

#### 5.3. Vice-President - Representative Teams - Mike Birmingham

I would like to start by thanking the membership for allowing me the opportunity to work on the executive and to all the current and many of the previous executive members for their help in

While it was an abrupt end to the season our representative programs had a great year culminating with our Major Midget Jr Sugar Kings being crowned OMHA Co-Champions. We want to continue to get more non parent coaches especially for Midget and Bantam ages, so we are making steps towards that happening more each year.

#### 5.8. Player Safety Committee - Kristy Allen

The start of the season was quite busy as Rowan's Law was being implemented. We worked hard to ensure that all Woolwich players and parents/guardians were communicated with and that they were able to review the information and complete the acknowledgement required as per the new OMHA guidelines. This was a collaborative effort and I thank all those who were involved in this process.

WMHA agreed this year to move away from individual concussion baseline testing and focus more on concussion education, awareness and prevention. We were fortunate to be able to partner with Sheila Bauman and Scott Jantzi from Woolwich Physiotherapy along with Dr. Patrick Bishop to host two information sessions for coaches and trainers and a session for all players born in 2008 along with their parents/guardians. This age group was targeted as PeeWee seems to be the level where we see more concussions happen. Those players born before 2008 would have sat through a similar presentation last year, although any who may have missed it previously were invited to attend if they wished to. There was a lot of positive feedback from those that attended the sessions.

We completed a review of our concussion parent and player resources that are housed on the website to ensure that all protocols were updated, added some new information and removed any outdated information.

We had a low number of reported suspected concussions and there were no issues with players, parents, coaches or trainers following the concussion protocol as it is laid out with everyone putting the safety and health of the player first.

#### 5.9. Equipment Committee - Kevin Brown

Thank you to all the coaches and managers for helping get the equipment out and returned this season.

Working with our budget, we are hoping to be able to purchase some new goalie equipment for the U8 age group and below this coming season to assist with the cost of those players wanting to play this position.

#### 5.19. Fundraising Committee - Kristy Allen

This year we continued to fundraise for the Association through the Elmira Sugar Kings Cash Calendars and we held a Spiritwear fundraiser as well.

The Cash Calendars raised \$5,530 for the Association and \$2,765 for teams. The Spiritwear fundraiser raised \$488.26 for the association. The total raised for the Association was \$6,018.26.

Teams continued to fundraise through pepperettes, events and other initiatives with those profits remaining with the teams.

Referee expense pretty much the same which means select didn't cost much but time keepers were up so we spend more there with select.

The cash flow is explained by the fact that we have been running a deficit for many years. The retained earnings at the beginning of the 2019-2020 season were -51949 and this profitable year brings them up to -8581. This is noticed in our association this year because we didn't have 4 on 4 and registration to float us.

#### 5.26. Website - Brett Bickerton

The website saw over 200,000 visitors this year, up from last even though we had a shorter season. Obviously with the abrupt suspension of the season, visitors dropped once we knew this was going to be a long break. I expect we will be slowly seeing visitors return to the website once details on the next season are available



We continue to use our website as the hub for WMHA information with a secondary emphasis on social media (Facebook, Twitter, Instagram). The website is based on a product from MBSportsWeb which is going through a rebrand to Sportsheadz. With this rebrand, we expect some changes to how the WMHA website will look and hopefully new features will be added. I will be handing over the administration of the website to Donna Harrington.

#### 5.26. Office / Registrar - Donna Harrington

- Q: Is WMHA planning on having a Juvenile team this season
  - A: We will poll the Juvenile players. Worried not enough interest.
- Q: Can select kids play in the competitive tier?
  - A: We will start prior year rep rosters. If there are openings, we will then go to the APs from the prior year. If there are still openings, we would look to the Select team.
- Q: Can you address how the teams would be made?
  - A: We will go to last year's coaches and ask them to rank them. Will factor in Major/Minor.
- Q: Any idea on the registration costs?
  - A: We have put forward a budget and are looking to cost out the new options. Hoping to give the same level of ice time. Pricing not confirmed yet.
- Q: Who would be included in the loop that the teams play against?
  - A: Only Woolwich. Rec will be like Local League. Only playing other kids in Woolwich.
- Q: Players who played up an age group, do they stay up with that group?
  - A: For rep, likely stay where they are. No new requests. Nothing for local league.
- Q: Will Rep have a different fee than Rec?
  - A: Yes. There will be more ice time. Development is still up in the air (WHA).
- Q: I saw pictures of kids playing in a summer hockey tournament. Are private leagues allowed to play?
  - A: Private is private, not the same governing body.
- Q: How will we handle an early bird registration that was previously paid?
  - A: If they don't plan to play, they will get a refund. Fees have not been finalized so there might be a difference.
- Q: For kids playing Major Peewee AE last season, will there be room for all of them to play in Batam?
  - A: Yes. There is one cohort that is bigger. We might need an extra tier.
- Q: Perhaps there could be smaller IP teams to allow for helpers. Issues around water and bathroom breaks.
  - A: Still needs to be worked out. Washrooms are currently closed. Perhaps a staggered start. Younger groups could start later when the rules are more relaxed.
- Q: Have the arenas advised of a change in schedule from 50 minutes?
  - A: There are rules around cleaning. Staff will wipe down the chairs, ledge etc... Still 10 minutes for flood, not extra clearing.
- Q: What protocol will there be around sharing of goalie equipment?
  - A: To be determined. Nothing has been set up yet.
- Q: Why was it decided to separate rec and rep based on last year?
  - A: OHF has said no tryouts/evaluations this season. All based on previous year.

- Q: No extra time for cleaning?
  - Currently, left group and right group and then cleaned accordingly.
- Q: Are we assuming the St. Jacobs rules will apply to the Woolwich Memorial Centre (WMC)?
  - A: Currently, yes. WMC. Could be more restrictive because of the pool, rec centre, seniors centre and walking track. Just recently received the guide from the township.
- Q: Will there be a need for kids to wear full helmet shields?
  - A: No. Nothing mandated at this time. This will be a new version of hockey with no physical contact. Trying to avoid direct contact. WMHA must complete a full Return to Play plan which must be approved by governing bodies.
- Q: Is there a protocol for any players that test positive for COVID?
  - A: We are working on that portion of our return to play protocol?
- Q: If it is not a rep team, can they play in a private league as well?
  - A: No. Players cannot play sanctioned and unsanctioned hockey?
- Q: Will rep players be required to sign an OMHA card?
  - A: No. For this season, rep players will not have to sign the offer of commitment form. All teams will be rostered.
- Q: Clarification on when coaches are absent (head coach and trainer)?
  - A: Can use the other teams trainer if in the same bubble. Same for coaches. Any personnel outside will need clarification from the OMHA.
