3) Treasurer Report – Deb Good

- Deb provided Budget vs Actual Statement April 1 through November 30, 2011
- Registration line includes Concussion fees, which need to be pulled out
- Rep team fees still some teams have not paid, emails have gone out
- Sponsorship money outstanding maybe \$450
- Gate receipts going well in St. Jacobs, Jodi does a great job
- Tom will send an email to Grand River that a fee needs to be paid, Steve and Deb to ask the township to help corrale people through the area to pay
- Goalie Clinics need to be discussed, advertised in the summer, freshened up with new instructors
- Board advertising cheque did come in from the Township

a. VP Rep – Paul Wilson

- TriCounty held Nov 16th, Banquet came and gone
- Rob, please inform all teams to carry a current rooster with them at all times
- Age appropriate timekeepers within the box, send any issues or concerns to Paul
- AAA tryouts, no excuses for OHF, regardless of Easter being later in the year, 14 days for AAA prior to AA going forward, concern of ice not being available
- WMHA needs to discuss one year trial, 28 games 2 tournaments (midgets 26 only) feedback prior to January, going back to 24 games and 3 tournaments

c. VP Coaching - Rob Waters

- Coaches meeting has been rescheduled for early January
- Info to be posted on the website and then emailed out to all coaches
- Overall minimal coach's complaints or issues
- Concussion Mgmt program needs to be invoiced
- 5 players have gone through the program, will request feedback to review their experiences
- Midget local league turnout is low for practices Tom will ask Dave to look into attendance, suggestion to have practice only once every two weeks

d. VP Player Dev – Eric Brubacher (absent)

- Goalie Clinic went very well with 12 goalies present although 20 had registered
- There is a struggle with lack of interest/commitment from players and goalie parents when we offer these clinics at no player cost with one of the top OUAA goalie coaches, on a full PD day across the region
- Would like feedback from the group
- Discussion ensued it was thought that changing up the date (no child wants to come on their day off from school), and change up the goalie coach to make it fresh, advertise it early, have it established in September when the clinic will be held

e. Ice Scheduler – Deb Good

- Local League many want to reschedule for the games for the December 17th
 weekend
- Two games need to yet to be rescheduled with Ayr

f. Office Administrator/Registrar – Jodi Young (absent)

- Finishing rostering the teams, all rep teams have approved rosters and almost all APs are complete, along with all coaches
- Local League still rostering perhaps next year Thanksgiving Weekend to have all teams rostered

g. Fundraising Committee – Diane Weigel

- All information distributed to those who stopped by to pick up, other calls have been made, requested an overall coach/manager list
- Pepperettes have gone up in cost \$3 cost, profit of \$2 per pack

- Possible suggestions at coaches meeting in the fall to have a sample budget for teams to put WMHA fundraising within the budget for rep
- Discussions around possible additional fundraiser in 2012

- There was an executive presence, OMHA rep, Head Referee within the building to help at all times, especially when discussion involved penalties
